Assistant Inspectors [redacted] and [redacted] interviewed Assistant District Attorney (ADA) [redacted] via telephone, telephone number [redacted]. After being informed of the identity of the interviewers and the nature of the interview ADA [redacted] provided the following information:

(U//~~FOUO~~) ADA [redacted] remembers receiving a text from Massachusetts State Police (MSP) Trooper [redacted] around 10:30 p.m. on May 21, 2013. ADA [redacted] does not remember exactly what was said but remembers it being very good news about the Waltham triple homicide investigation on which the MSP were interviewing Ibragim Todashev. ADA [redacted] headed to his office in anticipation of drafting an indictment. ADA [redacted] received another telephone call later in the evening from Trooper [redacted] around 11:50 p.m., although he does not remember the exact time. Trooper [redacted] told ADA [redacted] the interview was going well and Todashev was writing out his confession. ADA [redacted] thought the investigators were doing a good job from a legal stand point, stating they gave Todashev cigarette breaks, bathroom breaks, and allowed him to move around the room freely. Trooper [redacted] and ADA [redacted] continued to talk about certain aspects of the investigation when the call ended abruptly. ADA [redacted] did not think anything of the abrupt ending to the telephone call and in his experience, many law enforcement calls of that nature end abruptly.

(U//~~FOUO~~) ADA [redacted] then contacted [redacted] the Assistant United States Attorney (AUSA) in Boston. ADA [redacted] knew AUSA [redacted] would want to know Todashev was talking to the investigators. ADA [redacted] did not know the interview was going to be recorded and did not authorize or suggest the interview be recorded. ADA [redacted] was well aware of Todashev's violent history and criminal record. ADA [redacted] stated everyone involved in the case knew Todashev was a Mixed Martial Arts fighter and had a violent nature. When asked about DNA evidence found at the Boston triple homicide crime scene in Waltham, Massachusetts, ADA [redacted] stated it was not the District Attorney's office policy to comment or provide information on an ongoing investigation.
